The family groups represented in this collection may not be complete, because information was entered bit by bit as I found it or happened upon it; I have not done any systematic research on these families. Because they do not compose whole family genealogies, these listings are arranged differently from most genealogical records or histories. Each listing is a family group, and is arranged and filed alphabetically under the name of the head of the family.

Names are generally in alphabetical order (disregarding spelling variations and middle names), then in approx. chronological order. The first sorting is by surname (mixing together any and all spelling variations), then by given name, then by approx. birthdate (when known) in approximate chronological order. For easier reference, surnames in headings are grouped together under the most common spelling usage that evolved in this geographical location, regardless of individualistic spellings in the records themselves. Cross references are used in most cases where surname spellings substantially vary.

Within the quoted records, the individual spellings have been (mostly) retained because they sometimes provide clues (although in general—but with exceptions—they seem to largely reflect the record keeper's particular orthography and not always, at this early period, any special family preference). Those interested can see the variety and evolvement of a particular name's spelling and the interesting and sometimes amusing attempts at phonetic reproduction. Keep in mind that before names and spellings were standardized, records reflected the individualistic whim of the particular recorder (often two different spellings of the same name within the same document). In addition, all records were handwritten, and sometimes deciphering a handwritten name in early records can be quite challenging! So expect to search under all possibilities of spelling (for both surnames and given names).

Given names are grouped together without regard for middle initials or middle names. Because middle names and/or initials are sometimes used, sometimes not used in various records, it seemed simplest to arrange entries as if the middle names or initials did not exist. Usually all variations of a given name are grouped together as though spelled one way: Jan, Johannes, John, etc. are all grouped as one (but also look under the other forms).

Sources and references are included with each "family" grouping, but may or may not include sources that are cited (or are obvious, such as baptismal records, etc.) within the narrative or listing itself.

As with any compiled genealogical record, researchers should regard this information as leads and clues, and should verify all data with independent research.

In the record of their banns, they were: Peter Petro Alberto, j.m. Van Venetien, en Judith Jans, j.d. Van Amsterdam. Pietro Caesare Alberti was an Italian from Malamocco, near Venice. He was the first Italian to settle in New Amsterdam.³ He arrived in America June 2, 1635 aboard the ship "de Coninck". According to Captain David Peterson de Vries's sailing log, Pietro Alberti was a merchant seaman who joined the ship before July 10, 1634 at Texel, Holland. The ship arrived at New Amsterdam, America, June 2, 1635 where Pietro jumped ship. The log entries indicate Captain de Vries and Pietro did not get along, (maybe the reason he jumped ship). Pietro left Venice about 1632 and went to Holland. While in Holland Pietro renounced the Catholic faith and joined the Dutch Reformed Evangelical Church.¹

Pieter Caesar Alburtis lived at New Amsterdam, and later obtained, on 17 June 1643, a patent for a plantation at the Wallabout. In 1651 he sold a portion to Samuel Menjer; and the remainder was sold, after his death, to Jan Damen. He made his mark to documents in 1670.

Whereas Pieter Cecer, alias Mallemock, and his wife have lately died, leaving six small children",tutors and guardians appointed......"herewith appoint Pieter van Linde as being the stepfather of the mother"......Dated 9 November 1655.2

He came to America in 1715. Tradition has it that he was compelled to leave Scotland for political reasons, his services being enlisted in behalf of the Pretender. It is proof of his ability that the year after his arrival he obtained an appointment in the office of the Secretary of the Province of New-York, was appointed Surveyor-General of West Jersey, an office which he held for the remainder of his life, and was also appointed Receiver-General and Collector of Quit Rents for the Province of New Jersey. In 1718, under the first charter of Perth Amboy, he was appointed Recorder of that city. On coming to America he devoted himself to the study of the law, and soon became one of the foremost lawyers in New-York and New Jersey, though by profession he was a civil engineer. In 1721, under Governor Burnet, with whom he was very intimate, he was commissioned a member of the King's Council for the Province of New-York, holding office until 1737, and again from 1750 until 1756. In 1721 he was also made Attorney-General for New-York. In June, 1723, he was appointed naval officer for the port of New-York, and reappointed in 1728. In 1737 he was elected to the New-York Assembly for one term. He was commissioned a member of the King's Council for New Jersey, July 19, 1722, and held the office until his death. In 1728 he was one of the representatives of New Jersey to try pirates. He was a large landholder with extended interests, and a member of the Boards of Proprietors of both East and West New Jersey. For recreation he pursued his favorite science of astronomy,

and maintained a long correspondence with Halley, the eminent astronomer. He founded, with Benjamin Franklin and others, the American Philosophical Society. Writing of him in 1743, Lewis Morris says: "James Alexander lives in New-York, and has a very considerable estate in several parts of New Jersey. He is a merchant at New-York, and is supposed to be worth not less than £100,000. He is much troubled with the Gout, and doth attend the Assembly when the sessions are at Amboy, and has there been lay'd up with the Gout the greater part of the session of 1745."

In 1719 he was appointed a Commissioner for New Jersey to survey the boundary line between that province and New-York. Alexander was also one of the commissioners to survey the lands in dispute on the line between New-York and Connecticut, known as lands in the Oblong. Probably the most important matter with which James Alexander was connected was the celebrated trial of John Peter Zenger for libel.

James Alexander's will was dated 13 Mar 1745, recorded in Essex Co. 3 May 1756 along with codicils dated 17 Feb 1748 and 29 Sep 1749. In his will, he describes himself as "of New York City." The lengthy will mentions real and personal estate in large amounts. He mentioned his wife, Mary; son in law John Provost; sons James, deceased, and William; daus. Anne, Elizabeth, Katherine, Susannah, Mary. Executrix named is wife, Mary Alexander. Wits. were Arch'd Kennedy, Mary Kennedy, Evert Bancker. The 1748 codicil notes that dau. Anne had died since will of 1745.

Mary Alexander's will was dated 27 July 1756, had two codicils dated 27 Feb 1758 and 19 Feb 1760; the will and codicils were recorded in Middlesex Co. 16 May 1760. On 3 Nov 1762 William Alexander, Esq., Lord of Stirling, qualified as executor. In her will, Mary, widow of James Alexander, Esq., mentions eldest son, John Provost, merchant of New York City; late son David; son William Alexander; eldest dau. Mary Livingston (wife of Peter Van Brugh Livingston, merchant); dau Elizabeth (wife of John Stevens of New Jersey, merchant); dau. Catherine Parker, and her two ch. Clarinda and Bristoll; youngest dau. Susannah.

Joseph Warner Allen, surveyor of the route of the Paterson & Ramapo Railroad through Allendale, stayed with the family of John G. Ackerman on Franklin Turnpike in Allendale about 1846, while surveying in this area. When the station was

established, the stop was named "Allendale" in his honor.

He was a civil engineer. He began as a rodman during the construction of the old Delaware Division Canal and was engaged on the construction of the Camden and Amboy Railway at Bordentown. He was employed on the building of the Grand Gulf and Port Gibson Railroad in Mississippi and the Baltimore and Ohio Railroad in Virginia. After working for the Paterson and Ramapo Railroad, he was chief engineer of the Hoboken Land and Improvement Co., the Dundee Water Power and Land Co., and various railroad enterprises.

He was deputy quartermaster-general of New Jersey, and organized and equipped the first eight regiments of three years' volunteers for the Civil War. He was a colonel of the 9th New Jersey volunteers, and joined the Burnside expedition in North Carolina. He drowned off Cape Hatteras 15 Jan 1862 while on the Burnside Expedition. He was held in such high esteem by his fellow officers and men, that the survivors, two years later, in 1864, erected over his grave in Bordentown, a 15'6" marble memorial. It is inscribed as follows: "Joseph W. Allen, Colonel, Ninth Regiment, New Jersey Volunteers, drowned at Hatteras, North Carolina, January fifteenth, 1862, in the fifty-first year of his age." "This monument is erected by the officers and men of the Ninth Regiment, New Jersey Volunteers, as a tribute of grateful respect to the memory of their first commandeer, who, while faithfully serving his country in the darkest hour of her peril, even to the sacrifice of his life, endeared himself to the hearts of his whole command."

Also buried in the cemetery at Bordentown is James Warner Allen, b. 1 June 1825, d. 30 Nov 1901, who might have been Joseph Warner Allen's brother.

The will of "John Amory, of New York, mariner" was dated 20 August 1757 and probated 30 December 1762. In it, he left: to my wife Mary £500 and 1/2 of all my right and interest in the good ship, or vessell, called the "King William the Third," in which I am now going on a Privateering cruise against his Majesty's Enemies. I also leave to her 1/2 of all the profits that may come to me from said cruise. I also leave to my wife 1/2 of the rent and profit of the dwelling house in New York where I live until my son John is 21, for the bringing up and educating and supporting my said son. Also the use of furniture and £1,000. I leave to my son John £500 when of 25 years of age, or sooner if his mother thinks best to be put at interest on good bond security. I leave to my son John all that tract of 2,000 acres of land which I purchased of Lawrence Van Kleeck and his wife Jacopie, as by deed dated August 29, 1752, and after the death or marriage of my wife the dwelling house and lot where I now live, situate near the Vly Market, in New York, but the rent of 1/2 of the house shall be paid to Hester Rynders, the daughter of my wife by her former husband, so long as she remains widowed. If my son dies, then I leave the house and lot and 1/2 of the ship to the said Hester Rynders. I make her, and my wife, and my brother-in-law, John Cuyler, and my friend, James Van Cortlandt, executors. When the will was probated, Hester Rynders was then the wife of Stephen De Lancey. Pelletreau adds a note: Mary, wife of Captain John Amory, was the widow of Barent Rynders, Jr.3

Mary Amory, of New York, widow of John Amory, in her her will dated 20 October 1758 (Proved 28 Nov. 1758) mentions daughter Hester, son John... "all rest to be sold... and proceeds to my son and daughter when of age." Appoints her father, Henry Cuyler, and her brother, John Cuyler, executors. (Pelletreau, NYC Will Abstracts, Liber 21:138). ---children of John Amory & Maria Cuyler:

In Russell Gasero's "Historical Directory of the Reformed Church in America, 1628-1992" [1992] on page 5 we learn that Vincentius Antonides was born in Buxom, Friesland, the Netherlands in 1670. He was ordained at Leeuwarden in 1693. He was the Pastor at Bergum in Friesland, from 1693 until 1705, when he came to New York to minister to the people of Bushwick, Flatbush, Flatlands, Brooklyn, New Utrecht, Gravesend, and Jamaica. His pastorate lasted from 1705 to 1744.

In his will, he wrote: ...November 6, 1743. I, Vincentius Antonides, minister of the Gospel at Flatbush, being in good health. I leave to my eldest son Johanes, for his birth right, a negro boy, "John," aged ten years, and all the books in which I have written this in Dutch, "Dit book behoort tot myn zoon Johanes Antonides." Also all my writing library, both Latin and Dutch, and all the rest to my heirs, my son Johanes, my daughter Johana, wife of Cornelius Rapalye, and my grand-daughter Margareta, wife of Jacobus Vanderspiegel. I make my son Johanes, and my friends Jacobus Goelet and Peter Strycher, executors. Witnesses, James Remsen, Engelbert Lott, Jan Ditmarts. Proved, September 7, 1744.

A court document is found in Mortgages 1658-1660 of the Early Records of Albany series -- where Goosen Gerritsen [Van Schaick], Adiraen Jansen Appel and Philip Hendricksen appear as sureties for the fine of Steven Jansen (Conninck) at Fort Orange and Beverwyck in 1659. There is no further detail as to what this fine is for.¹

In 1671, Adriaen Appel had recently been a resident of New York, but had removed to Albany. In 1674 he was an innkeeper.

He was a member of the party who in 1659 attacked the Indians at Esopus; they remembered, and retaliated by attacking and killing him in his home 7 June 1663. Only a few days before this his wife Grietie Hendricks and little daughter Annetie had reached their home from a visit to Wie, by Swolle, in Holland, Grietie's birthplace.

Jan Aertsen was a blacksmith, and settled at Esopus (Kingston). He joined the church at Esopus on 15 April 1661, and soon after was made an elder.

Richard Ashfield was a merchant of New York. He inherited a propriety in East Jersey.¹

He came to America soon after the Duke of York had confirmed the sale of East Jersey to the proprietors. He was a nephew of Thomas Hart of Enfield, Middlesex (England), merchant, one of the 24 East Jersey proprietors. Thomas Hart dying in 1700, his right in East Jersey descended to his sister and heir, Patience Ashfield, from whom it descended to her grandson and heir, Richard Ashfield. He had, therefore, one whole propriety in East Jersey (NY Gen. & Biog. Record, vol. 6, p. 21; NJ Archives, x, p. 131). Probably he moved to East Jersey and died there, for 5 April 1714, Richard Ashfield, about 18 years old petitioned for the appointment of Capt. He was in the milling business in Texas in his youth and afterwards was one of the largest manufacturers of cotton bags in the country.

He was instrumental in securing the incorporation of Mount Vernon, NY, and one of his proudest possessions was a silver loving cup presented to him by the inhabitants of Mt. Vernon.

He was for a number of years superintendent of Jennings' hardware works at Port Jervis (1890).

I leave all the rest of my personal estate to the Rector and Wardens of Trinity Church for clothing and educating poor children of the Charity School. According to the 1633 version of De Laet's Nieueu Wereldt, the Machkentiwomi, neighbors of the Tappaans, lived "over against" the Manhattans on the west side of the Hudson River. Their name derives from machkachtaeuunge, meaning red bank of a river. Where was Machkachtaeuunge? According to the deed of Daniel Honan and Michael Hawdon, dated June 5, 1696, a tract of vacant land in Orange (now Rockland) County, New York, was commonly called Kackyacktaeueke. Presenting another version of this place-name, the Return of a Survey for 7,470 acres, dated April 25, 1710, issued to Elias Boudinot, John Auboyneau, John Barberrie and Peter Fauconnier mentions "an Indian field called Maygahgtayako" situated on the southwest side of Pascack Brook in present-day Spring Valley, New York. This Indian plantation, variously known as Kackyacktaweke, Hackyackawack or Maygahgtayako, is the origin of the historic toponym Kakiat. These place-names appear to be approximations of Machkachtawunge, thus placing this band near the head of the Pascack Creek and perhaps southward. Furthermore, in 1657, Augustine Herrman purchased a tract of land lying west of the mouth of the Raritan River running to a creek (?) at the uppermost end of the Great Marsh called Mankachkewachky, which runs northwest up into the country. Mankachkewachky appears to be another approximation of Machkachtawunge. Therefore, the Mechkentowoon resided upon intertidal lands bordering Newark Bay and its tributaries, the Hackensack and Passaic Rivers.

A ship sailed from La Rochelle for Quebec on 8 April 1656. It was owned by one Auboyneau. Either he was in Nantes or the ship was built in France. The ship was 3-masted and was 100 tons. The name of this vessel was either "Fortune" or "La Fortune."
