

-- **BOELE, BOELEN** --

The family groups represented in this collection may not be complete, because information was entered bit by bit as I found it or happened upon it; I have not done any systematic research on these families. Because they do not compose whole family genealogies, these listings are arranged differently from most genealogical records or histories. Each listing is a family group, and is arranged and filed alphabetically under the name of the head of the family.

Names are generally in alphabetical order (disregarding spelling variations and middle names), then in approx. chronological order. The first sorting is by surname (mixing together any and all spelling variations), then by given name, then by approximate birthdate (when known) in approximate chronological order. For easier reference, surnames in headings are grouped together under the most common spelling usage that evolved in this geographical location, regardless of individualistic spellings in the records themselves. Cross references are used in most cases where surname spellings substantially vary.

Within the quoted records, the individual spellings have been (mostly) retained because they sometimes provide clues (although in general—but with exceptions—they seem to largely reflect the record keeper's particular orthography and not always, at this early period, any special family preference). Those interested can see the variety and evolvement of a particular name's spelling and the interesting and sometimes amusing attempts at phonetic reproduction. Keep in mind that before names and spellings were standardized, records reflected the individualistic whim of the particular recorder (often two different spellings of the same name within the same document). In addition, all records were handwritten, and sometimes deciphering a handwritten name in early records can be quite challenging! So expect to search under all possibilities of spelling (for both surnames and given names).

Given names are grouped together without regard for middle initials or middle names. Because middle names and/or initials are sometimes used, sometimes not used in various records, it seemed simplest to arrange entries as if the middle names or initials did not exist. Usually all variations of a given name are grouped together as though spelled one way: Jan, Johannes, John, etc. are all grouped as one (but also look under the other forms).

Sources and references are included with each "family" grouping, but may or may not include sources that are cited (or are obvious, such as baptismal records, etc.) within the narrative or listing itself.

As with any compiled genealogical record, researchers should regard this information as leads and clues, and should verify all data with independent research.

I welcome, and would be grateful for, any additions or corrections, especially with source citations.

In his will, he wrote: ...I, Abraham Boelen, of New York, shopkeeper, being well in health, I leave to my wife 1/3 of all estate, and to my daughters Elizabeth and Anna each 1/3 when of age. I leave to my cousin, Hendricus Boelen, 6 shillings. I make my wife Elizabeth, and my father-in-law, Abraham Kettletas, and my brother-in-law, Matthew Clarkson, executors. Dated April 3, 1735. Witnesses, Abraham Vanderheul, John Vanderheul, Nicholas Vanderheul. Proved, July 15, 1742.

Matthew Clarkson was then dead.

He was from Uffelte (modern spelling) in Drenthe, Netherlands.

Boele Roelofszen, his wife, and three children, besides his wife's sister and a boy, arrived in New Amsterdam from the Netherlands sailing on 12 Feb 1659 on board *De Trouw*^{1,2}. Accompanying them was Bayken's sister, Tryntie Arents, who, within a few months of arrival, was betrothed to Gerrit Jansen Roos. The entry for their passage is: Boele Roeloffszen Jongerman...his wife and three children-- of 2 and 3 years and a nursing child--besides his wife's sister and a boy of 14 years [Boele Roelofszen, Joncker, and wife and four children, besides his Wife's sister and a boy¹].

Boele Roelofszen was a farmer and tailor from Friesland.

Boele Roelofszen may have been the brother of Annetje Roelofs, who m. (banns: 2 May 1659 NYC Ref Ch), Ryck Hendrickszen [Riker].

Jacob Boelen, Bayken Arents, witnessed the baptism 24 Jan 1685 NYC Ref Ch, of Bayken, dau. of Willem Hellacken & Tryntie Boelen.

Boele Roelofszen & Teuntje Theunis Wed; van Jan Stryker, witnessed the baptisms 28 March 1697 NYC Ref Ch, of Willem, son of Willem Hellaken & Tryntje Boelen.

In the marriage record, they were: Hendrick Baelenszen, j. m. Van N. Yorck, en Anneken Cours, j.d. als boven, beyde woonende alhier.

In his will, he wrote: I, Henry Boelen, of New York, smith, being sick and weak. I leave to my wife, Antie Berents, the use of all my estate during her life, and she shall give to her son Alexander [error for Abraham?], when of age, such portion as she can conveniently spare, and after her decease he is to be sole heir, and if he should die the estate to go to Boelen Roeloffs, my father. If my wife should remarry she shall secure to my son Abraham Boelen £125, and he is to be instructed to read and write, and afterwards to learn a trade by which he shall live in the future. He is also to have my great Dutch Bible as a particular gift and legacy." Makes Roeler Roeloffen, Jacob Boelen, Dirck Ten Eyck tutors and overseers, and his wife executor. Dated May 15, 1691. Witnesses, A. De Lanoy, P. De Lanoy. New York, December 10, 1691, there appeared before me, being

authorized by Governor-General Benjamin Fletcher, the above named witnesses, and made oath to the same, that they saw Henry Boelen sign and seal the same. David Jamieson, Dep. Sec.

Hendricus Boelen was a goldsmith-silversmith, succeeded to his father's business in 1729.

In his will, he wrote: ...I, Henricus Boelen, of New York, goldsmith, being weak in body. I leave to my loving son Joseph 10 shillings. I leave to my wife Jannettie the use of all my estate during her life, with full liberty to sell any of my negro slaves. After her decease I leave all my estate to my children, Joseph, Anna, wife of Christian Frederick Arter, and Catharine. I make my wife Jannettie and my children executors. Dated August 11, 1755. Witnesses, Jacob Goelet, Samuel Laurence, John Burnet, Esq. Proved, September 22, 1755. Confirmed by Sir Charles Hardy, Knight, Governor.

Oerter, of "Bethlem," and to Ann and Catharine Oerter, daughters of the said Christian Fred. Oerter to be divided amongst them equally. In case of the death of Henry Boelen, son of my brother, Jacob Boelen, before he is of age, then his share to go to the said children of the said Christian Fred. Oerter or the survivors of them. I make my brother, Jacob Boelen, silversmith, of City of New York, Christian Frederic Oerter, of Bethlehem, and his son, Henry Oerter, executors. Dated January 7, 1778. Witnesses, John Houseman, painter and glazier, Dav. Thompson, cordwainer, Simon Breasted, cooper. Proved, April 9, 1781.

A notice of Catharine's death in a contemporary newspaper said: "Widow Catharine Boilen died April 2, 1772, aged 82 years, 7 months. She was the youngest of 6 sisters named Waldron. Three lived to an old age. Judith 85, Anne 84, Mary 80, Sarah and Cornelia now living, the former 89, the latter 84 years 5 months. The total being 505 years. Their mother died in her 95th year of a Scratch in her Arm which mortified."

In the marriage record, they were: "Jacob Boelen, j.m. Van Amsterd., en Catharina Klock, j.d. Van N. Yorke, beyde woonende alhier."

Jacob Boelen was a goldsmith in New York City. He was the outstanding craftsman of his time. He was admitted freeman of NYC in 1698 as a goldsmith.

In his will, he wrote: I, Jacob Boelen, of New York, goldsmith, being in good health. I leave to my wife Catharina, all my estate, real and personal, lands, and goods, for life. And after her death, I leave to my granddaughter Catharina, the only child of my eldest son, Isaac, deceased, £3, when she is of age or married. I also leave her all that my house and lot where I now live, in the Broad street, between the houses and lots of Ursilla Van Dyck and William Roseboom. I leave to my son Henricus, all that my house and ground, now in his tenure, in New York, fronting the Dock, behind Queen street, between the lots of Anna Vanderspiegel and Cornelius Langevelt, which lot is to contain the whole breadth of the lot, and to extend back towards Queen street, sixty-three feet, to the remainder of my ground, with all my right to the Dock. I leave to my son-in-law, Jacob Goelet, Jr., and my daughter Catharine, his wife, all that my large house and ground, now in his occupation, fronting Queen street, between the houses of Anna Vanderspiegel and Cornelius Langevelt. To contain the whole breadth, and to extend back to the lot left to my son Henricus, being 70 feet 2 inches, with the privilege of a water course over the said lot to the river. And they are to pay £100 to my son Henricus, and ú200 to my nephew, Coenraet Ten Eyck (son of Dirck), cord-wainer, to be put at interest for my granddaughter Catharina. I leave all my personal estate to my granddaughter Catharina, and my son Henricus, and to Jacob Goelet and his wife. I make my wife Catharina, and my son-in-law, Jacob Goelet, and my son Henricus, and my nephew, Coenradt Ten Eyck, executors. Dated July 31, 1725. Witnesses, Abraham Gouverneur, John Walters, John Marshall. Proved, March 23, 1729/30.
