# -- CLAES, CLAESZEN --

The family groups represented in this collection may not be complete, because information was entered bit by bit as I found it or happened upon it; I have not done any systematic research on these families. Because they do not compose whole family genealogies, these listings are arranged differently from most genealogical records or histories. Each listing is a family group, and is arranged and filed alphabetically under the name of the head of the family.

Names are generally in alphabetical order (disregarding spelling variations and middle names), then in approx. chronological order. The first sorting is by surname (mixing together any and all spelling variations), then by given name, then by approximate birthdate (when known) in approximate chronological order. For easier reference, surnames in headings are grouped together under the most common spelling usage that evolved in this geographical location, regardless of individualistic spellings in the records themselves. Cross references are used in most cases where surname spellings substantially vary.

Within the quoted records, the individual spellings have been (mostly) retained because they sometimes provide clues (although in general—but with exceptions—they seem to largely reflect the record keeper's particular orthography and not always, at this early period, any special family preference). Those interested can see the variety and evolvement of a particular name's spelling and the interesting and sometimes amusing attempts at phonetic reproduction. Keep in mind that before names and spellings were standardized, records reflected the individualistic whim of the particular recorder (often two different spellings of the same name within the same document). In addition, all records were handwritten, and sometimes deciphering a handwritten name in early records can be quite challenging! So expect to search under all possibilities of spelling (for both surnames and given names).

Given names are grouped together without regard for middle initials or middle names. Because middle names and/or initials are sometimes used, sometimes not used in various records, it seemed simplest to arrange entries as if the middle names or initials did not exist. Usually all variations of a given name are grouped together as though spelled one way: Jan, Johannes, John, etc. are all grouped as one (but also look under the other forms).

Sources and references are included with each "family" grouping, but may or may not include sources that are cited (or are obvious, such as baptismal records, etc.) within the narrative or listing itself.

As with any compiled genealogical record, researchers should regard this information as leads and clues, and should verify all data with independent research.

I welcome, and would be grateful for, any additions or corrections, especially with source citations.

He immigrated, with, probably, his wife and widowed mother in 1653. He was a potter. In 1657 he became a small burgher and bought a house and lot in New Amsterdam, and set up a pottery. He had a Bouwery at Harlem, and was Magistrate there.

John Archer, sheriff, presents Dirck Clausen, pot baker, for that on August 16, 1679, being Sabbath day morning, did make an assault upon one William Phillips, and with his knife, the nose of said Phillips did sorely cut that it hung down over his lipps, which is contrary to Law and the Peace of our Soverign Lord the King, etc. Report of Sheriff, that upon examination of said matter, he found that the daughter of said Dirck Clausen, pot baker, had by her impudence enticed William Phillips to come into bed to her, where her father, the pot baker, finding them, caused the disturbance. The act being found to be evil, she was committed to the Sheriff's custody. John Archer, Sheriff, presents Lysbet Dircks, daughter of Dirck Clausen. That not having the Fear of God before her eyes but being tempted by the instigation of ye Devill, did upon a Sabbath day morning, October 16th instant, suffer William Phillips to come into the bed to her. And the father of said Lysbet, coming, found the said Phillips in bed with his said daughter, which is to the evil example of others, and is a breach both of the Law of God and man and against the Peace of our Lord the King.

In the (2) marriage record, they were: "Dirck Claeszen, Wedr.. Van Weyntie Roelofs, Pottebacker, en Anneken Dircks, Wede. Van Evert Janszen."

Agreement [apparently made after Dirck Claesen's third marriage]. Appeared before me, Wm. Bogardus, Notary Public, residing in New York, admitted by the Rt. Hon. Edmond Andross, Knight and Lieutenant-Governor, etc., under his Royal Highness, James Duke of York and Albany, etc. Dirck Clasen Pottbacker, widower of Amertie Dircksen, on the one part. And John Rea, as being married Clarision, the daughter of the first wife of the said Dirck Clasen, viz. Wyntie Roelofs, and giving him power, also for Janetie married with Cornelis Dircksen, and Gretie married to Barent Christians. As also of John Everts being a son of his second wife, Amertie Dirckse, being assisted by Mr. Boele Roeloffsen, and Hugh Barents de Cleyn, requested in this same, and also by desire to speak for Gisbertse, a maid under age, of the afore said Dirck Clasen, procreated by the aforesaid Amertie Clasen, "they all declaring that they have agreed in friendly love with each other as follows," The said widower Dirck Clasen Pottbacker, shall have possession of the whole estate, and after his decease, the three first children of said Wyntie Roeloffs are to have one half, which shall be in common with his present wife, Mettie Elberts, and the aforesaid children shall have 300 guilders, wampum value; the remainder is to go to the children of the second wife, Amertie Dircksen, namely John and Gisbertse. "And they are to have each one half of a certain corner called Pottbackers corner, with all that is depending thereon; being situated near the out watering of the Fresh water into the East river, and next into Henry Breasier's." The girl is to remain in her father's house, till she is married, and John is to remain in the service of his father for six months. They all agreed and sign this document, March 15, 1678/9. Thomas Dongan, Lieutenant-General and Governor. To all, etc. Know ye that at a Court of Record held in New York, November 2, 1686, before Nicholas Bayard, Esq., Mayor, the Inventory of the estate of Dirck Clasen was brought into Court by his wife Mattie, and Letters of administration are granted to her November 20, 1686.1

Appeared before me Wm. Bogardus, Notary Public, Dirck Clasen Pottbacker, bridegroom, and Mettie Elberts bride to be, assisted by Bay Crosvelts and Cornelis Vanderburgh her chosen overseers. Agreeing by God Allmightys permission to marry each other. They also agree that each party shall bring in all their goods and personal property, none excepted, with which the Allmighty God has blessed them, and the profits and losses are to be to them equally. And after the decease of either, the survivor shall have one half, and the heirs of the deceased to have the remainder." March 15, 1678/9

The corner called the Pottbackers corner was a small point of land at the present south corner of Cherry and James streets, New York, the stream which was the outlet of the Freshwater (or Collect Pond) ran into the river at this point. This stream was the boundary between the Montgomery Ward and the Out Ward. In 1794 this stream had been filled in and so completely obliterated, that its original location was unknown, and an Act was passed establishing a new boundary between the wards. The land of Henry Breasier was on the north side of Cherry street between Roosevelt and James street.<sup>1</sup>

To all, etc. Know ye that at a Court of Record held in New York, November 2, 1686, before Nicholas Bayard, Esq., Mayor, the Inventory of the estate of Dirck Clasen was brought into Court by his wife Mattie, and Letters of administration are granted to her November 20, 1686.

We Nicholas Delaplaine, Boele Roelofsen, Theophilus Turford and Hendrick Jansen, in obedience to an order of the Court of Mayor and Aldermen, dated the 19th of October, 1686, to make an inventory of the estate of Dirck Clasen, etc. "The lot of ground with the old house thereon situated and lying in the Heer Gracht," £75. "The lot of ground and old house, situated in Petticoat Lane, £25. Total amount, £126. Sworn to November 1, 1686. Note: The house and lot on the "Heere Gracht," is on the east side of Broad street, about 30 feet south of Beaver street. It was previously the house of Nicasius De Sille.

In the NYC Ref Ch marriage banns record they were: Sybolt Claeszen, j.m. Van Hoorn, en Susanna Jans, wed. Van Aert Theuniszen. (Aert Theunissen Van Putten was massacred in 1643 by Indians at Pavonia.)

Sibout Claessen was no doubt cousin-german [first cousin] to Harck Siboutsen [Krankhyte] from Langedyk on the river Kuinre, in the district of Zevenwolden, or Seven Forests.<sup>1</sup>

He called his parcel in New Netherland, patented to him 5 June 1646, after his native place, Hoorn's Hook.

A power of attorney was granted by Cosyn Gerritsen to Sybolt Claessen, to receive a legacy left him by Susanna Ellfertsen in Hoorn, in 1649.2

In his will, he wrote: Sybout Claasen, New York. [This will is written after the ancient Dutch form.] On the 10th day of February in the year 1678/9 appeared before me Wm. Bogardus, Notary Public, Sibout Claasens being sick, and his wife Susannah Jans, of indiferent health, but both of perfect memory. Both declare that "of real love and affection during the time of their matrimony shown to each other, and by the blessing of God yet to be shown." Each bequeaths his share of the estate to the survivor. They leave to the Deacons of the Dutch Church for the poor, 1000 guilders, wampum value. After their death the estate is to go to her two children by her late husband Arent Teunisen, viz. Susannah, wife of Reynier Williamson, and Weyntie, wife of Simon Barentz. Witnesses, Evert Petersen, Sybert Jansen. Translated from the Dutch by Nicholas Bayard. Proved at Court of Record, New York, February 8, and confirmed and administration given to Susannah Jans the survivor, February 16, 1680. Anthony Brockholls.

William moved to Piscataway, NJ possibly by 1687, when he purchased property there. However, according to Warren Cruise's Croesen Families of America, p 325, William Klaas sold his 27 acres of Staten Island property to Sander Egberts who was married to Elsje Pieters Staats, 1st cousin of Elsje Croesen. Therefore on 17 May 1696 Elsje was obviously dec. as she is not mentioned in the deed of sale -- but William is listed in the deed as "of Staten Island" not New Jersey. [Croesen: 328] so it would seem that he had not yet moved to Piscataway.
