The family groups represented in this collection may not be complete, because information was entered bit by bit as I found it or happened upon it; I have not done any systematic research on these families. Because they do not compose whole family genealogies, these listings are arranged differently from most genealogical records or histories. Each listing is a family group, and is arranged and filed alphabetically under the name of the head of the family.

Names are generally in alphabetical order (disregarding spelling variations and middle names), then in approx. chronological order. The first sorting is by surname (mixing together any and all spelling variations), then by given name, then by approximate birthdate (when known) in approximate chronological order. For easier reference, surnames in headings are grouped together under the most common spelling usage that evolved in this geographical location, regardless of individualistic spellings in the records themselves. Cross references are used in most cases where surname spellings substantially vary.

Within the quoted records, the individual spellings have been (mostly) retained because they sometimes provide clues (although in general—but with exceptions—they seem to largely reflect the record keeper's particular orthography and not always, at this early period, any special family preference). Those interested can see the variety and evolution of a particular name's spelling and the interesting and sometimes amusing attempts at phonetic reproduction. Keep in mind that before names and spellings were standardized, records reflected the individualistic whim of the particular recorder (often two different spellings of the same name within the same document). In addition, all records were handwritten, and sometimes deciphering a handwritten name in early records can be quite challenging! So expect to search under all possibilities of spelling (for both surnames and given names).

Given names are grouped together without regard for middle initials or middle names. Because middle names and/or initials are sometimes used, sometimes not used in various records, it seemed simplest to arrange entries as if the middle names or initials did not exist. Usually all variations of a given name are grouped together as though spelled one way: Jan, Johannes, John, etc. are all grouped as one (but also look under the other forms).

Sources and references are included with each "family" grouping, but may or may not include sources that are cited (or are obvious, such as baptismal records, etc.) within the narrative or listing itself.

As with any compiled genealogical record, researchers should regard this information as leads and clues, and should verify all data with independent research.

I welcome, and would be grateful for, any additions or corrections, especially with source citations.

He was a trader and a Justice of the Peace in Albany in 1715.

Caatje Cuyler witnessed the baptism 16 Feb 1690 Albany Ref Ch, of Marretje, dau. of Gerrit Claasz.

In his will, he wrote: May 11, 1742. I, Abraham Cuyler, of Albany. I leave to my eldest son, Hendrick Cuyler, £10, in right of primogeniture, also my house and lot in Albany in the 2nd Ward, where I now live, bounded west by Pearl street, east by another street formerly called the Wagon Way, north by Nicholas Bleecker, and south by Joseph Ten Eyck, and Stephen Groosbeek. The said house is valued at £400, which is to be paid to my children, Johanes, Margarita, wife of Dirck Ten Broek, Sarah, wife of Johan Beekman, Catharine, wife of Coenraet Ten Eyck, Abraham, and Nicholas. I leave to my sons Abraham and Nicholas, all of my house and ground in the 1st Ward in Albany, on the hill fronting Jonckers street, bounded east by Jeronimus Wendell, west by the heirs of Gerritt Wingart, in length and breadth according to deeds; also a lot in Schenectady, on the north west part of the town, as granted to me by the heirs of Philip Philipse, as by deed dated May 24, 1734; Both being valued at £250, to be paid to the rest of my children. To my sons Abraham and Nicholas all my wearing apparel, and my negro Jack. I leave to my sons Hendrick, Johanes, Abraham, and Nicholas all the rest of my estate, lands in the Mohawk country, at or near Ticondaroka flats, according to deeds. And all the tract at Skoharie alias Hunters field, in

Albany County, granted to me by Timotheus Vrooman, October 16, 1736. The whole is valued at £330, to be paid to my other children. I leave to all my children all my lot of land in Albany, on the hill near the city fence, and also all my part in the Patent of Weston Hook. I make my sons executors. Witnesses, Ephraim Wendall, David Van der Lyde, Johans Bleeker. Proved, October 10, 1747.

Barent Cuyler, prob. this individual, graduated from King's College (now Columbia) in the class of 1763.

Barend R. Cuyler's will was dated 16 December 1771, proved 26 February 1772 (Pelletreau, NYC Abstracts of Wills, Vol. VIII, p. 22 [Liber 28: 197]). Ibid, p. 140: [from newspapers of the time]...Barent Cuyler, merchant, died in Barbadoes, in the fall of 1771.—W.S.P.

In his will, he wrote: "...I, Barend R. Cuyler, of New York, merchant. I direct all debts to be paid. I leave to my sister Mary my negro wench "Moll," which I purchased of Mr. John Livingston, and £150. I leave to John Brunkhoost £250, for his faithful service. I desire my brother Henry to keep my watch and give it to his eldest son. I leave all my plate and household furniture to my brother Henry and all my sisters. I leave all my interest and estate in the Sugar House, erected by my late father in New York, and the land buildings and utensils to my brother Henry, and he is to pay to each of my sisters £30 each, yearly for seven years, and then pay them £500 each, and my estate is charged with the same. All the rest of my estate I leave to my brother Henry and my sisters, Mary Alida, Hannah, and Hester. "In case my sister Mary shall marry Doctor John De Normandy of Bristol, Pennsylvania, I give all the money left to her to my brother Henry and my other sisters. And my brother Henry and my executors shall not pay any money to her except on receipt of a bond, to be forfeited if she marries him." "And whereas it may be thought doubtful if I have power to dispose of my right in the Sugar House, it being not yet sold according to the directions of my father's will, I am influenced by a persuasion that I can rely upon my brother's integrity, lest those who after his death may be entitled to his estate may not merit the same confidence, and if he or his heirs shall claim the same, on the principle of being my heir, then I leave the property I have left to him, to my sister Mary (in case she does not marry Dr. De Normandy) and to my other sisters." I make my brother Henry, and my friends, William Imlay and John Jay, executors. Dated December 16, 1771. Witnesses, Archibald Mercer, Smith Ramage, Benjamin Jones. Proved, February 26, 1772.

He was from Hasselt, Overijssel, Netherlands. He was a tailor. He immigrated before 1660. He was in Albany circa 1664. Hendrick bought a lot on the hill, on the east side of North Pearl Street near State Stree, west of Pearl "near ye Fort". After his death this passed to his son in law, Pieter Van Brugh. In 1675 he made his brother Reynier, his attorney to receive certain property of Pieter Nicolass Gouverneur.

Hendrick Cuyler was Alderman of Albany in 1687; Lieut. of Capt. DePeyster's company; Captain of the Fort in 1689; Major in 1689; one of Leisler's Council in 1689.

In his will (written in low Dutch, by his own hand), he wrote: In the name of God, Amen. "Be it known that I, Henry Cuyler, on this March 21, 1690, in the 2d year of His Royal Majesty King William, being fully resolved to make my will and testament while I am in health." My whole estate is to remain in possession of my wife, Anna Cuyler, so long as she remains my widow. If she remarries she shall be obliged to give two thirds to my children, John, Abraham, Sarah, Delia, Rachel, Maria, Eva, and Henry. Over whom I appoint as tutors and guardians, [brothers-in-law] Geritt Vanderburgh, John Van Giesen and John de Wandelaire. My first born son shall have £10 more than the rest, my youngest son, Henry, shall have my Gold ring, my seal and a silver spoon. "The above I have written with my own Hand." Witnesses, Captain Geritt Duyckinck, Ensign Peter De Mill, translated by Abraham Gouverneur, 17 Nov 1690.<sup>1</sup>

In her will, she wrote: In the name of God, Amen. Be it known and manifest unto all people, that I, Anna Cuyler, widow of Henry Cuyler, late of this city, merchant, being at the present time of sound memory, although very sick and weak." All the articles, clauses, and legacies, in the will of my late husband, and provisions established by my late husband in his will, are to be fully performed, bearing date March 21, 1690, written by my said husband and signed in presence of Geritt Duyckinck and Peter De Mill, and written in Low Dutch language, and on which I obtained letters of administration, November 17, 1690. Before any division is made of my estate, my executors are to pay to my daughter Mary, £100, and the sum of £120 to my daughter Eve. It being my custom to give so much to each of my daughters at their marriage for their wedding apparell, which they have had. All the rest of my estate, real and personal, is to be divided among my children in eight equal parts, my son Johanes is to have one share provided he signifies his approval of the will of his father, but if he does not do so, he is to be excluded. And one share to each of my children, Abraham, Henry, Sarah, wife of Peter Van Brugh, Delia, wife of Johanes Grovendyke, Rachel, wife of Myndert Schuyler, Mary and Eve. I make my sons, Johanes and Abraham, and my son in law, Peter Van Brugh, Johanes Grovendyke and Myndert Schuyler and my daughter Mary, executors. Dated in New York, July 3, 1702. Witnesses, David Provoost, Isaac De Reimer, Abraham Gouverneur. Proved, March 18, 1702/3, and the above executors confirmed.<sup>2</sup>

Henry Cuyler was a merchant and trader and owner of several vessels. He lived in King Street and had a store and vendue room, known as Cuyler's Vendue Room. He was Captain of a militia company in New York in 1738, and his name appears on a Poll List in New York City, 1761.<sup>1</sup>

In his will dated 23 July 1763, probated 20 Dec 1766, he wrote: I, Henry Cuyler, of New York, merchant, being in good health. All debts and funeral charges to be paid. My executors are to make a true inventory of all my estate, and convert the whole into money within three months. My executors are to sell my dwelling-houses, storehouses, and lots in New York and elsewhere. I leave to my eldest son, Henry, £10 for his birthright. I also leave him £1,000. I leave to my son, Telemann Cuyler, £1,000; To my son John £1,000; To my daughter Anne, widow of Richard Langdon, £800; To my daughter Sarah, wife of Thomas Bayeux, £800, provided she gives up the bond by which I am bound to pay her £40 yearly for life; To my daughter Rachel, wife of John Hansen, £800, but the interest only is to be paid to her at the discretion of my executors; To my daughter Catharine, wife of Isaac Latouch, £200; To my daughter Elizabeth, widow of John M. Cleve, £800; To my granddaughter Hester, wife of Stephen De Lancey, £300; To my grandson, John Amory, £300 when of age. The rest of my estate I leave to all my children. And whereas all my executors are indebted to me, what they owe is to be considered part of their shares. I make my sons executors. Dated July 23, 1763. Witnesses, William Livingston, Michael Jeffrey, Robert R. Livingston, Jr. Proved, December 20, 1766.

The following appeared Monday, 2 Feb 1767 in *Gaine's Mercury*: All persons who have any Concerns with the Estate of Mr. Henry Cuyler late of the City of New York, deceased, are desired to bring in their accounts, settle with the Executors and discharge their Debts. The Dwelling House &c, where the deceased lately lived, to be Let; a Negro Wench and a Negro Boy to be sold at public Vendue, on Thursday the 5th of February inst. at the Merchants' Coffee-House, or by private agreement any time before. Enquire of Henry and Telemann Cuyler, Executors. In the *Mercury* for 1 June 1767, a list of his real estate was published as follows: The House and Lot in which he lived, now in the possession of Andrew M'Myer. A House and Lot of Ground, situate on Cruger's Dock, now in Possession of John and Thomas Burling. Several houses, Store Houses, in the Possession of Andrew M'Myer. A tract of land in the Oblong, No. 53, containing 500 acres. A small Lot of Land in the Town of Hackensack. Several lots of Land in the Great or Hardenburgh Patent. This notice was signed by Henry, John, Telemann, and Abraham Cuyler, his sons and executors.<sup>1</sup>

In his will, he wrote: ...I, Hendrick Cuiler, of Albany, I leave to my wife Margaret the use of all my estate during widowhood, provided she maintains my children as usual, during the time she remains my widow. I leave to my son Abraham my silver Tankard, for his right of Primogeniture. "I leave to my daughter Elizabeth, when married, £100 and my silver tea pot, in lieu of an outset." I also leave her the income of 1/2 my estate while unmarried. I leave to my son Abraham 1/2 of my real estate, and the other half after the marriage of my daughter Elizabeth, and I value it at £500. I leave to my daughters, Catrintie, wife of Jacob Van Schaick, Catalina, wife of Hendrick Bleecker, Jr., and Elizabeth, each £500. All the rest of my estate to my children. I make my son Abraham, and my brother, Nicholas Cuiler, executors. Dated March 11, 1761. Witnesses, Johannes Roseboom, John Glen, Abraham Yates, Jr. Proved, March 17, 1767.

Henry Cuyler's will is given in Pelletreau. NYC Abstracts of wills, Liber 27: 317: I, Henry Cuyler, of New York, merchant, being at present but weak and in a poor state of health. I leave to my sons Henry and Barent R. Cuyler all my sugar house and land and dwelling house and stables, and all utensils and two negro men, and they are to pay to my wife yearly £360 during her life. I leave to my wife the use of all household goods, plate, and servants during her life and then to my six children. I leave to my sons Henry and Barent and to John Smyth, of North Amboy, New Jersey, Esq., all my Proprietor Rights in East New Jersey to sell and pay debts, and the rest to my children. My executors are to sell all the rest of my estate and divide the proceeds among my six children. I make my sons Barent and Henry and John Smyth, executors, and John Smyth is to have £100 Stirling for his trouble. Dated, August 29, 1770. Witnesses, William Ludlow, George Ludlow, William W. Ludlow. Proved September 29, 1770.

Note—Henry Cuyler, a prominent member of a prominent family, died after a lingering illness, at Perth Amboy, September 17, 1770. His funeral at his house in New York was attended by a large number of people. "He was buried in the New Dutch Church Yard."—W.S.P.

Henry Cuyler was ordered by the Provincial Congress to remove from his house in Newark on account of adherence to the crown, but permitted, by vote, 17 July 1776, because "so extremely indisposed as to rende his removal very dangerous," to remain for the present, give his parole, and a bond with security in penalty of £1000.

Henry Cuyler's will is given in Pelletreau, Vol. XI, NYC Abstracts of Unrecorded Wills Prior to 1790, p. 197: Henry Cuyler, at present of the township of Newark in the Province of New Jersey...my share of the lands in the Eastern Division of New Jersey are to remain unsold, and my executors are to locate my rights in future divisions...mentions two children, Henry and Catharine, both under age...three sisters, Oleda [Alida in other sources], Hannah, wife of Nicholas Ogden, and Hester (Hester is under age)....Dated July 17, 1776; proved August 28, 1777. Note—A part of the estate of Henry Cuyler was a lot on the south side of Dock Street (now Pearl Street) formerly owned by Samuel Bayard. On the east side of this from Water Street to South Street runs Cuyler's Alley. The lot from Water Street to Front Street was sold by the executors of Henry Cuyler, to Peter Messier. The lot on Pearl Street running south to Water Street was sold to Isaac Low, and was confiscated and sold after the Revolution. The lot is now No. 82-1/2 -84 Pearl Street.—W.S.P.

On 1 November 1793, James Parker and Abraham Ogden, two of executors of the estate of Henry Cuyler, the elder, and Henry Cuyler, the Younger, conveyed to Abraham Fashun [Farsher>Forshay] of Franklin Township, for £53.25, 30 acres...corner to John Fell. Signed James Parker, Abraham Ogden. Witnessed by David A. Ogden, David B. Ogden.<sup>1</sup>

On 1 January 1794 (recorded 2 June 1804, Bergen Co. S:237) James Parker and Abraham Ogden, two of the Trustees of the Last Will & Testament of Henry Cuyler the Elder and Henry Cuyler the Younger, deceased, conveyed to Stephen Bertholf of the Township of Franklin, for £92, 19 shillings, three tracts totalling 232-38/100 acres in the Township of Franklin, part of a tract called the Ramapough patent, known as lots No. 106, 109, and 110, as follows: (1) 56-67/100 acres, Lot No. 106, beginning corner Lot No. 105 at a corner of the Lareaux tract; (2) 58-24/100 acres, Lot No. 109, beginning corner of Lot 108 in Lareaux line; (3) 117-47/100 acres, Lot No. 110, beginning corner of Lot No. 109 in Lareaux line. Signed by James Parker, Abr<sup>m</sup> Ogden. Witnessed by David A. Ogden, David B. Ogden.<sup>2</sup>
