The family groups represented in this collection may not be complete, because information was entered bit by bit as I found it or happened upon it; I have not done any systematic research on these families. Because they do not compose whole family genealogies, these listings are arranged differently from most genealogical records or histories. Each listing is a family group, and is arranged and filed alphabetically under the name of the head of the family.

Names are generally in alphabetical order (disregarding spelling variations and middle names), then in approx. chronological order. The first sorting is by surname (mixing together any and all spelling variations), then by given name, then by approximate birthdate (when known) in approximate chronological order. For easier reference, surnames in headings are grouped together under the most common spelling usage that evolved in this geographical location, regardless of individualistic spellings in the records themselves. Cross references are used in most cases where surname spellings substantially vary.

Within the quoted records, the individual spellings have been (mostly) retained because they sometimes provide clues (although in general—but with exceptions—they seem to largely reflect the record keeper's particular orthography and not always, at this early period, any special family preference). Those interested can see the variety and evolution of a particular name's spelling and the interesting and sometimes amusing attempts at phonetic reproduction. Keep in mind that before names and spellings were standardized, records reflected the individualistic whim of the particular recorder (often two different spellings of the same name within the same document). In addition, all records were handwritten, and sometimes deciphering a handwritten name in early records can be quite challenging! So expect to search under all possibilities of spelling (for both surnames and given names).

Given names are grouped together without regard for middle initials or middle names. Because middle names and/or initials are sometimes used, sometimes not used in various records, it seemed simplest to arrange entries as if the middle names or initials did not exist. Usually all variations of a given name are grouped together as though spelled one way: Jan, Johannes, John, etc. are all grouped as one (but also look under the other forms).

Sources and references are included with each "family" grouping, but may or may not include sources that are cited (or are obvious, such as baptismal records, etc.) within the narrative or listing itself.

As with any compiled genealogical record, researchers should regard this information as leads and clues, and should verify all data with independent research.

I welcome, and would be grateful for, any additions or corrections, especially with source citations.

In the Bergen Ref Ch record of their marriage intentions they were: "Jan Roelofse Eltingh, Y.M., and Jacomyntje Sleck (widow of Gerrit Fooken) both living at Esopus. Received certificate to be married at Esopus, November 24, 1672."

Jacomyntje Slecht had four children with her first husband, one of whom, Tryntje, m. Solomon DuBois of New Paltz.

Jan Eltinge signed the treaty made by the Paltz Huguenots and the Indians, in the spring of 1677, as one of the witnesses. On the 8th of June, 1686, Jan Eltinge and Gerrit Aertson, his son-in-law, and Arien Post bought a lot of land at Rhinebeck; "Right over against the Rondout Creek" by a small creek called Quaanawoss.

Quit Claim Deed -- To all Christian people to whom this present writing shall come, Roeloff Eltinge of the New Paltz, in the Co of Ulster and Province of New York in America, Yeoman, Cornelius Eltinge of Marbletown in sd. Co., yeoman, William Eltinge of Kingston in sd. Co., Carpenter, Ger. Van Wagenen, of Kingston, aforesaid yeoman, Geertje Hall widow of Thomas Hall late of Raretan in the Co. of Somerset in J. J. Gerrit Wynkcoop, Helitje his wife of Philadelphia in Penn, yeoman, Jannetje Newkerk widow of Cornelius Newkerk late of Hurley, Ulster Co. Henry Pauling and Jacomynte his wife of Philadelphia in Penn., yeoman, Greeting. Now know ye, that, whereas Jan Eltinge, late of Hurley in Ulster Co., did by his last will and Testament bequeath to his five children, Reoloff, Cornelius, William, Geertje Hall and Altje Eltinge, mother of the aforesaid Gerrit Van Wagenen, one just half of his estate, and the other half to Jacomynte Pauling, Roeloff, Cornelius and William Eltinge, Gerrit Van Wagenen, Geertje Hall, Tryntje, late wife of Solomon Dubois of New Paltz, and in consideration the children of said Dubois of their just right should be assured, the said [here follow the names of the heirs] have granted, etc., to the children of said Dubois, one just ninth part in the lot No. 5 lying in Dutchess co. over against Rondout Creek, bounded Northerly by lot of Evert Van Wagenen, Easterly by a creek, Southerly by land of Evert Roosa, Westerly by Hudson River. Also a just eighteenth part in a certain Meadow commonly called Jacomynte's fly. To have, hold, etc August 1 1729. Sealed and delivered in the presence of Johannes Shepmoes, Hendrik Pruyn, Nicholas Hofman, John Cock, George Hall, Henry Stevens, Henry Pauling, Gerrit Wynkoop, Jannetje Newkerk, Hilletje Wynkoop, Jacomyntje Pauling, Roeloff Eltinge, Cornelius El[t]ing, Willem Eltinge, Ger, Van Wagenen.³

In his will, he wrote: ...(Written in Dutch language.)--In den Name des Heeren, Amen. Know all men that on the 5 of September, 1750, I, the undersigned, Johanes Eltinge, of Marble Town, in Ulster County, farmer. I leave to my eldest son Petrus for his birth right my Great Bible. I leave to my wife Janettie the income of all my estate during her widowhood. To my son Ruloff a negro slave and all my wearing apparell. I leave to my son Ruloff and my daughter Sarah a tract of land lying on the west side of the New Paltz Patent. All the rest of my estate I leave to my 3 children, Ruloff, Maybe, and Sarah. I make my two brothers, Josias and Noah Eltinge, and Hendrick Jansen, executors. "Done at Kingston in Ulster County." Witnesses, Jan Eltinge, Rachel Eltinge, William Eltinge. Proved before John Crooke, Esq., June 5, 1755.

Roeloff Eltinge settled at New Paltz about 1720. He was one of the justices of the county before moving to New Paltz. He became a man of much influence in the little settlement, and in 1728 was still one of the justices of the county.

In his will, he wrote: I, Roeloff Eltinge, of the New Paltz, in Ulster County, being weak and sick. I leave to my son, Noah Eltinge, all and singular my farm, lands, meadows, dwelling house and tan vats and tan mill, and all appurtenances, now in my possession, situate and lying within or near the limits of the Patent of the New Paltz, on the southeast side of the Paltz creek, between the land of Solomon Dubois and the land of Daniel Dubois; Also all those lots on the north west side of the Paltz creek, and the land commonly called the Great piece, lying in two parcels; Also all that the 1/3 of 1/6, and 1/16 part of all the undivided lands within the bounds of the Patent of the New Paltz, except as hereafter given; Also 1/2 of a certain tract of land by me purchased of Cornelius Dubois, the whole containing 528 acres; which 1/2 is the north west part thereof. My son Noah is to furnish my wife Sarah an honorable maintainance, that is of eating and drinking, lodging, apparell, attendance, and all other things necessary, and he is to pay to my daughter Jacomintie, wife of William Credeback, £100, and to my grandson Roelof, son of my son Abraham, late of Potumack, deceased, £100, and the same to my daughter Margaret. I leave to my son Josiah all those several lots of land in the Patent of New Paltz, which I have purchased of my brother-in-law, Abraham Dubois, with the dwelling house, and now in his occupation; Also 1/3 of 1/6 and 1/60 part of the undivided lands; Also 1/2 of the land I bought of Cornelius Dubois, and is the southeast part. And he is to pay £20 yearly to my wife, and £300 to my other children, and grand child, viz.: to my children, John, Noah, Janettie and Margaret, and my grandchild Roeloff. I leave to my eldest son John, for life, and then to his sons, Peter and Roeloff, 1/2 of all my right in sundry lots in the Patent of New Paltz fronting upon Hudson river, to begin at the distance of 1 1/2 miles from the river, and to extend west so far as the lots extend. I leave to my sons Josiah and Noah all my 2/3 part of 2 lots of wood land lately laid out in the Patent, one of them on the west side of the Paltz river in the Pine woods, "by a spring between the Horpon and the Klyn Bontekoe;" Also all my right in the woodland to the northwest of the lots of Daniel Dubois and Samuel Bevier, near the Hopon; and the other lot is also on the west side of Paltz creek, adjoining south to the land of Isaac Le Fevre, and upon the Bever creek; Also my undi-

vided part of another lot of woodland, "lying between the Hopon and the Spaase See," which said tract was divided to the heirs of Christian Deyo. I leave to my daughter Margaret, wife of Abraham Bevier, my 2/3 of 2 lots of wood land on the west side of Paltz creek and adjoining each other, and known as lots No. 3 and 4, "lying in a piece of land commonly called the Olynueton;" Also all my right in Lot No. 1, lying between Moghoonck and a lot of Jan Le Fevre, "commonly called Fontyntre," which was also divided to the heirs of Christian Deyo. If my wife Sarah shall not be satisfied to live with my son Noah, but shall choose to live with my son Josiah (She being of her natural senses at the time of such change) he shall allow her the same maintainance. I leave to my daughter Janettie, £40. To my son Noah, my negro man, wagons, oxen plows, etc. To my daughter Margaret a negro girl. To my son John all the money he owes to me. I leave to my grandson, Roeloff Eltinge, £100, due me from his father. To my son Noah, £100. I leave to my son John a certain tract of land in Kingston with the Tan vats. All the rest to my children and grand children. If any of my children shall sell their land they shall give the preference to their brothers and sisters at the same price a stranger will pay. I make my sons executors. Dated October 29, 1745. Witnesses, Petrus Loww, Jean Le Fevre, F. Bruyn. Proved, before John Crook, Esq., January 13, 1747.

Eltje Jurians Tappen m. (2) about 1692, Abraham DeLameter. Abraham DeLameter, of Kingston, in his will dated 20 Oct 1730 mentioned "my wife's daughter, Jannettie, wife of William Eltinge."

In his will, he wrote: written in Dutch language, Recorded Liber 15, Page 212.--In den Naame des Heeren, Amen. Be it known to every body that on the 7 day of December, 1743, I, the undersigned William Eltinge, of Kingston, in Ulster County, being sick and in poor bodily condition, considering the briefness of life, and being desirous to set all things in order. And concerning my temporal estate, I direct all debts to be paid. I leave to my eldest son, Jan Eltinge, for his right of primogeniture my Great Bible; I also leave to my son Jan the corner house and lot and barn where he now lives, and it is to be valued at £70, which sum he shall pay to all my heirs. I leave to my sons, Jan and Jacobus, the foremost orchard and meadow ground, which I have purchased partly from the Trustees of Kingston and partly from Lewis Dubois, and part from Solomon Dubois; To be to them equally. My son Jan is to have the part next to the meadow of Jan Osterhout, Jr., and it is to be valued at £50, which he is to pay to my heirs. And my son Jacobus is to pay £50 for the other half. I leave to my son Jacobus my piece of low land situate on the north side of the Great Kill, and which I purchased from Cornelius Low; Also 6 acres of the "Poor farm," situate on the east side of Fox Hall strand road, or path, and on the north side of the Kalckoon Hook (Turkey Point) path, as sold to me by the Trustees of Kingston. And he is to pay £145 to my heirs. I leave to my son Hendricus the house, barn, and lot where I now live, with all thereto belonging, as sold to me by Aldert Keerstede; Also 5 acres with the orchard, situate on the north side of the meadow of the heirs of William Schepmoes, and on the south of the land of Johannes Low; Also 8 acres in the Kleyn Vly (Little Valley), which I bought of Barent Benthuisen; Also 4 acres on the "first Poor Farm," situate between a lot of my son Jan and a lot of Johannes Ten Broeck; I also leave him 2 cows and my Schiet Roer (gun or musket) and a hand saw, broad axe and augur and 6 Bytells (chisels), the best in my Winckle (store), and all my woolen clothing. And he is to pay £184 to my heirs. And he is to take into the house his two sisters, Jannettie and Annettie, so long as they are unmarried, and to furnish them good support, provided they assist him as is proper. And when they are married they are to have 12 chairs, and a spinning wheel and bedstead and beds. I leave to my said daughters for their out set when married £30 and a cow and 8 sheets. I leave to my son Hendricus and to my daughters so much provisions as are necessary until July. I leave to my 7 children, Jan, Jacobus, Hendricus, Elsie, wife of Isaac Van Campen, Jacomyntie, wife of Noe Eltinge, Jannettie, and Annettie, each 1/7 of the £499 to be paid by their brothers, and all the rest of my present estate. I make my three sons executors. Witnesses, Gilbert Livingston, Johannes Moster, Cornelius Persen. Proved, February 13, 1743.

Wilhelmus Eltinge, from Kingston, NY, was the pastor of the Paramus Reformed Church c. 1799-1850. He also served the Saddle River Reformed congregation (then a separate church, but connected with Paramus Ref Church) from 1799-1811. From abt. 1811 until his death, Eltinge lived at Totowa. According to his gravestone at Valleau Cemetery, he was licensed to preach 22 April 1798; ordained and installed 22 Sep 1798; [pastor of Paramus Ref Ch] 30 June 1799; resigned 23 April 1850.

Eltinge was a trustee of Queens College (now Rutgers).

On 28 May 1806 (recorded 3 June 1806, Bergen Co. Y:40) Elijah Rosegrant MD of the Township of Franklin, conveyed to Rev. Wilhelmus Eltinge of the same place, for \$250, 7 acres in Franklin Township, beginning W side of road leading to Paramus Church; land of Abraham Rattan. Signed by Elijah Rosegrant. Witnessed by Lawrence C. Ackerman, William Quereau.²

At the time of the 1850 Federal Census, Wilhelmus W. Eltinge, 73, Ref. Dutch Clergyman; and Jane Eltinge, 65, were living with Augustus Hasbrouck and his family.
