The family groups represented in this collection may not be complete, because information was entered bit by bit as I found it or happened upon it; I have not done any systematic research on these families. Because they do not compose whole family genealogies, these listings are arranged differently from most genealogical records or histories. Each listing is a family group, and is arranged and filed alphabetically under the name of the head of the family.

Names are generally in alphabetical order (disregarding spelling variations and middle names), then in approx. chronological order. The first sorting is by surname (mixing together any and all spelling variations), then by given name, then by approximate birthdate (when known) in approximate chronological order. For easier reference, surnames in headings are grouped together under the most common spelling usage that evolved in this geographical location, regardless of individualistic spellings in the records themselves. Cross references are used in most cases where surname spellings substantially vary.

Within the quoted records, the individual spellings have been (mostly) retained because they sometimes provide clues (although in general—but with exceptions—they seem to largely reflect the record keeper's particular orthography and not always, at this early period, any special family preference). Those interested can see the variety and evolvement of a particular name's spelling and the interesting and sometimes amusing attempts at phonetic reproduction. Keep in mind that before names and spellings were standardized, records reflected the individualistic whim of the particular recorder (often two different spellings of the same name within the same document). In addition, all records were handwritten, and sometimes deciphering a handwritten name in early records can be quite challenging! So expect to search under all possibilities of spelling (for both surnames and given names).

Given names are grouped together without regard for middle initials or middle names. Because middle names and/or initials are sometimes used, sometimes not used in various records, it seemed simplest to arrange entries as if the middle names or initials did not exist. Usually all variations of a given name are grouped together as though spelled one way: Jan, Johannes, John, etc. are all grouped as one (but also look under the other forms).

Sources and references are included with each "family" grouping, but may or may not include sources that are cited (or are obvious, such as baptismal records, etc.) within the narrative or listing itself.

As with any compiled genealogical record, researchers should regard this information as leads and clues, and should verify all data with independent research.

I welcome, and would be grateful for, any additions or corrections, especially with source citations.

John Fell was the senior member of the merchant firm of John Fell and Company of New York, who had several armed merchant vessels in overseas commerce as early as 1759¹³. In 1786 he was also senior member of the firm Fell and Graham, doing business at 2 Crugers Wharf on the East River¹². He had been involved in river boat trade on the Hackensack and

Passaic Rivers.

Susanna Marschalk was the widow of Charles McIntosh (Mackintosh), son of Phineas McIntosh and Elizabeth Alsop, and by him she had two children: Phineas McIntosh and Susanna McIntosh. Charles MackIntosh was a merchant of New York City. Charles MackIntosh died before 3 February 1749 while he was on the voyage back home from London and left his wife, Susanna, and two children, Phineas and Susanna. Shortly after his death, the widow was married again, this time to John Fell, on 2 December 1749. Susanna and Phineas MackIntosh were raised in the Fell household in NJ (Petersfield).

Mackintosh, Charles, formerly of New York but late of St. Martin in the Fields, Middlesex, who died at sea. Administration to the principal creditor. Alexander Mackintosh; the relict and the children having been cited but not having appeared. (June 1749). Declared null and administration with will granted to John Fell, husband and attorney of the relict, now Susanna Fell, in New York. (June 1750).8

On 15 Aug 1752 Robert Gilbert Livingston and his wife [Catharina McPhaedris], in consideration of £365, conveyed to John Fell, merchant, and Susanna his wife, a parcel of ground in the West Ward of the NYC "fronting on the south by the side of the slip that leads from Queen Street to Countesses Key." (N.Y. Deeds, Lib. 37:205)³
John Fell lived at what is today Allendale, Bergen Co., NJ in a house still standing at 475 Franklin Turnpike (he called his

estate here Petersfield); he later moved to Coldenham, NY where he died.

John Fell may have had a sister, Anna Magdelen Fell, who m. Hendrick Jacobszen; they had a dau. who married Henry Cuyler, a NYC merchant who was also involved with shipping.

John Fell was an important and influential man in Bergen County. He was a justice of the peace in Bergen County, a member of the Provincial Congress, a member of the New Jersey Council, and a member of the Continental Congress.

Nero, a Negro servant of Judge Fells, a tory from Ramapough, was captured and taken prisoner in Clinton's raid on English Neighborhood, 19 Dec. 1776.

The will of "Garrit Miller, of Smith's Clove, Precinct of Cornwall, Orange County, N.Y." (dated 5 Oct 1777; John Fell was a witness) was probated at Petersfield, Bergen County, N.J. 13 June 1778. The name Petersfield was still in use in 1803 when it was cited as a place in Bergen County Deed R:186.

John Fell was taken prisoner by Loyalists and jailed in N.Y.C., 1777-78.

Fell's house on Beaver St. in Manhattan was burned by an arsonist after the Revolution. He and his wife were too elderly to start another household in N.Y.C. and moved upstate to Coldenham in Orange Co. to live with their children, who had married into the Colden family.4

"The Mansion House formerly belonging to John Fell, Esq. but now in possession of Peter Tebow" was mentioned in Bergen County deed R:182, dated 1 July 1803.

They lived in Wall St., NYC until, with the Revolution, he bought a country place, which he named "Salisburgh," in New Cornwall, Orange Co., NY, to which he moved his family for greater security. Here he entertained such dignitaries as Mr. & Mrs. George Washington, Gen. Lafayette, and Mr. & Mrs. Alexander Hamilton. After the war, they moved back to Wall Street and later, to 341 Broadway, where they lived at the time of his death in 1819. He was a New York State Senator in 1808. Amy Hawxhurst d. 7 May 1808.9
- Susannah Mackintosh (McIntosh), m. 1771 Paramus NJ, (Hon.) Nathan Smith. He was b. Huntington, L.I.; d. 1798 Ulster Co., NY. They lived at Hunting Grove, Ulster Co., NY where he ran a general store, grist mill, saw mill, and fulling mill. In 1776 he was made a member of the New Windsor Committee of Safety and Observation. During the same year his name appears on the records as one of the associate justices of the Court of Common Pleas. From 1777 to 1793 he was almost continuously a nember of the State Legislature. In the last year named he was appointed first judge of Ulster County Common Pleas and served as such until his untimely death in 1798¹⁰ They had children:

Henry Cosby was one of the two sons of William Cosby, Governor of New York (who died in 1736). Peter Renaudet, physician, of Great Britain, was mentioned and named as an executor in the will dated 22 May 1790, probated 31 July 1790, of Elizabeth Beekman, widow of John Beekman, of New York City, merchant. At the time of probate, Peter Renaudet had "since removed beyond the seas" and administration was granted 26 Aug 1790 to Thomas Leaming of Philadelphia, Attorney, a friend of the testatrix.²

On 22 Jan 1827 Charles Rhind wrote to John Jay endeavoring to procure an admission to West Point for his nephew, Peter Fell. The latter's great-grandfather, Judge John Fell, was a member of Congress from New Jersey at the time of John Jay's presidency and appointment to Spain. He records in his journal of their having dined together repeatedly. Judge Fell was later seized by an armed force in Paramus and was imprisoned at York for nine months. His son, Colonel Peter R. Fell, died of sufferings encountered during the Revolution. Has collected testimonials from those who knew both men, and would appreciate a statement from Jay that he recollects them. Though not known to him, Rhind is a personal acquaintance of Peter Augustus Jay.²

Before the Civil War, John R. Fell worked for the (Cotton) Commission House of Foley, Avery & Co., in New Orleans⁴. John R. Fell, a bookkeeper, served in the Civil War in the Confederate Army, Louisiana Volunteers, First (Nelligan's) Infantry, as a private (and later Sergeant) in Capt. C. W. Squires Co. B of the Battalion of Washington Artillery, This company was organized in April 1861 as Company B, 1st (Nelligan's) Regiment Louisiana Volunteers. It was detached from that regiment and assigned to duty as an Independent Field Artillery Company by S. O. No. 272, Headqrs., Richmond, Va., dated July 25, 1861, and subsequently became Capt. Green's Company (Louisiana Guard Artillery). John R. Fell enlisted 14 Aug 1862 and was discharged due to disability March 1863 at Richmond, VA (he was allotted payment to travel 1220 miles to New Orleans, LA). His right elbow was struck by a cannonball at the Battle of Rappahanock Station, VA, 25 Aug 1862, which carrued away portions of the bones in the elbow, rendering the right arm disabled. John R. Fell was a 2d Lieut. in Capt. Green's Co. in Nov-Dec 1861. On 25 Aug 1862 at the Battle of Rappahannock, John R. Fell's right arm was disabled, so that he had to write with his left hand.⁴

He was a Lieut.-Col. of Bergen County Militia, in command of a company which he and his father raised and equipped. Margaret Colden was the granddaughter of Lieut.-Gov. Cadwallader Colden.

Peter Renaudet Fell was bondsman for the marriage license for Dr. Samuel Bradhurst & Mary Smith, 16 Dec 1778. Peter R. Fell was bondsman for the marriage license of Aaron Burr & Theodosia Prevost 4 July 1782.

He raised a regiment of militia, and was elected by the New York Legislature to be Lieutenant Colonel of the First Regiment of Bergen County Militia, March 27, 1778. He devoted himself so zealously to the service, and exposed himself so recklessly that he became hopelessly crippled with rheumatism, and rejoined his command Oct. 5, 1779. He subsequently, however, acted as aid to Gov. Clinton, of New York, during the last two years of the war. Being sent on some duty from West Point, where Gov. Clinton was, he had the good fortune to be present at the taking of Stony Point, where he acted as a volunteer in the assault. After the war he settled in New York, following his father's mercantile pursuits, but on account of failing health withdrew from that occupation, and retired to Coldenham. There he spent his time overseeing his estate, causing himself to be carried about in a chair.

On 22 Jan 1827 Charles Rhind wrote to John Jay endeavoring to procure an admission to West Point for his nephew, Peter Fell. The latter's great-grandfather, Judge John Fell, was a member of Congress from New Jersey at the time of John Jay's presidency and appointment to Spain. He records in his journal of their having dined together repeatedly. Judge Fell was later seized by an armed force in Paramus and was imprisoned at York for nine months. His son, Colonel Peter R. Fell, died of sufferings encountered during the Revolution. Has collected testimonials from those who knew both men, and would appreciate a statement from Jay that he recollects them. Though not known to him, Rhind is a personal acquaintance of Peter Augustus Jay.5

Simon de Felle was captain, with Jacque de la Motthe, master, of the French Man-of-War (armed with 5 guns), the *St. Charles*, in 1654.⁶

5 Oct 1654 -- Francois La Marquies, pltf. v/s Symon Velle. deft. Pltf demands from deft. as successor to Capt. Thos. Dandamie, payment of fl. 800 according to obligation dated 20th April 1654, drawn by the aforesaid Thomas Dandamie in presence of deft. and another being witnesses. Deft. acknowledges to have succeeded Capt. Dandamie, and states that a bill of exchange was given to pltf payable in France or Tortovis (?) and therefore maintains, that he is not bound to pay here. Pltf requests that deft. shall be security for the payment, inasmuch as he is not sure, that the Bill will be accepted, the rather as ther Drawer of the same and of the obligation is dead--or that he be allowed a guarantee on the bark. Demand and reply having been heard by the Court, defendant being in the place of Capt. Thomas D., was condemned in compliance with pltf's request, to give sufficient security that the Bill of Exchange shall be paid; or in default thereof, pltf shall have his guarantee on the aforesaid Bark.⁴

In the marriage record they were: Simon Fell, Van Diepen in Vranckryck, en Anneken Vincent, Van Amsterdam. Simon Felle was a Frenchman from Dieppe in Normandy, he had purchased a house and a small plot of ground from Adrieen Vincent. Four years later he married Anneke Vincent of Amsterdam, a daughter of Adrieen.²

Simon Fel, along with Magdaleentie Birjaer, witnessed the baptism 3 Nov 1655 NYC Ref Ch, of Marinus, son of Jean Prie & Sophia Leenderts.

Simon Fel, along with Adriaen Vienzan and Anna Vienzan, witnessed the baptism 1 March 1656 NYC Ref Ch, of Andries, son of Jean de Pre & Margariet Jans.

In 1656, Egbert Van Borsum, keeper of the Brooklyn Ferry and keeper of tavern(s) at the Ferry, sued Capt. Beauline, Nicholas Boot, Jacob Huger, and Simon Felle for 310 florins for an entertainment given at his tavern, at which there were 14 persons present. In answer to the complaint, Capt. Beauline said that he had arranged for the entertainment and would pay half, but the others should pay the remainder due. The court decided that the Capt. should pay the entire amount because the agreement had been made with him alone.

23 Sep 1659 -- Adriaan Vincent and Simon Felle, pltf. v/s Lysbet Willems, deft. Anneken Felle, wife of Simon Felle, appears in Court also, interpreting the demand of her father, whoi says he was out yesterday, and that in the meanwhile deft. came to her house making agreat noise, saying amonf other things that the abovenamed Anneken had slept with Capt. Beaulieu, requesting redress for such injuries, which he cannot suffer. Deft. denies it, saying she had said--She, meaning Anneken aforesais, may go to Capt. Beaulieu; she knew, what she has to do with him; whereas it was told her, that she went with Capt. Roosyn, and she knew, what she had to do with him; which is denied by Anneken Felle. Pltf says he can prove, that

deft. has said that his daughter Anneken Felle had slept with Capt. Beaulieu. Parties appear in Court and Lysbet Willems is asked, if she knew any thing against Anneken Felle; Answers, has nothing to say against her. She therefore sharged to remain quiet for the future and to utter no more such infamous words, and to keep herself still.⁵
