

-- MANDEVILLE --

The family groups represented in this collection may not be complete, because information was entered bit by bit as I found it or happened upon it; I have not done any systematic research on these families. Because they do not compose whole family genealogies, these listings are arranged differently from most genealogical records or histories. Each listing is a family group, and is arranged and filed alphabetically under the name of the head of the family.

Names are generally in alphabetical order (disregarding spelling variations and middle names), then in approx. chronological order. The first sorting is by surname (mixing together any and all spelling variations), then by given name, then by approximate birthdate (when known) in approximate chronological order. For easier reference, surnames in headings are grouped together under the most common spelling usage that evolved in this geographical location, regardless of individualistic spellings in the records themselves. Cross references are used in most cases where surname spellings substantially vary.

Within the quoted records, the individual spellings have been (mostly) retained because they sometimes provide clues (although in general—but with exceptions—they seem to largely reflect the record keeper's particular orthography and not always, at this early period, any special family preference). Those interested can see the variety and evolvement of a particular name's spelling and the interesting and sometimes amusing attempts at phonetic reproduction. Keep in mind that before names and spellings were standardized, records reflected the individualistic whim of the particular recorder (often two different spellings of the same name within the same document). In addition, all records were handwritten, and sometimes deciphering a handwritten name in early records can be quite challenging! So expect to search under all possibilities of spelling (for both surnames and given names).

Given names are grouped together without regard for middle initials or middle names. Because middle names and/or initials are sometimes used, sometimes not used in various records, it seemed simplest to arrange entries as if the middle names or initials did not exist. Usually all variations of a given name are grouped together as though spelled one way: Jan, Johannes, John, etc. are all grouped as one (but also look under the other forms).

Sources and references are included with each "family" grouping, but may or may not include sources that are cited (or are obvious, such as baptismal records, etc.) within the narrative or listing itself.

As with any compiled genealogical record, researchers should regard this information as leads and clues, and should verify all data with independent research.

**Mandeville**

"Gillis Jansen De Mandeville, from Garderen, in the Veluwe, Gelderland, ancestor of the American family of Mandeville came out in [the ship Faith, a private trader going to the Manhattens," which sailed February 13, 1659...Gillis (often written Yellis) or Giles De Mandeville was accompanied by his wife Elsie Hendricks and four children, having two born afterward, one being David. Yellis bought a farm at Flatbush, which he finally gave to his eldest son Hendrick, and got the grant of another, of 30 acres, at Greenwich, on Manhattan Island, laid out to him December 5, 1670, and patented December 30, 1680. Here he died between 1696 and 1701. All of his children married. He had but the two sons, both of whom left descendants. David remained on the farm at Greenwich. Hendrick removed from Long Island to Pequannock, N.J. These have given several pastors to the Reformed Church, including Rev. Giles Henry Mandeville, D.D." — Riker, James, History of Harlem, p. 100 footnote

He lived at Cortlandt Manor, or Peekskill, NY. He went from Garrison, Putnam Co. (then Dutchess), to Cortlandt Manor where he bought 64 acres from Schurman Travis on 2 Dec 1752, and 99 acres on 4 May 1763 from William Horton. His holdings were in the heart of Peekskill.<sup>1</sup>

He lived first at Hempstead, L.I., NY and later purchased land at Pompton Plains and Pacquenac, and lived in a stone dwelling on the east side of the road opposite the brickyards.

On 18 March 1684, Adam Mott, Jr. sold to Hendrick Mandefell 50 acres in the south woods at Hempstead' Peter Johnson Scoll on 14 June 1684 gave 50 adjoining acres to his beloved son-in-law Hendrick Mandefell.<sup>5</sup>

On 11 May 1695, having purchased the Indian title to the same, Major Anthony Brockholst and Capt. Arent Schuyler in behalf of themselves and their associates, Samuel Bayard, George Ryerson, John Mead, Samuel Berrie, David and Hendrick Mandeville, obtained a patent for 5,500 acres of land from the East Jersey proprietors at Pacquenac, or Pompton Plains, NJ.

In his will, dated 2 Aug 1709, Pequannock, Essex Co., NJ, Hendrick Mandeval mentioned wife, Elizabeth. Children--David, Antie Brouwer, Hendrick, Johannes, Yelles (under age). Wife sole executrix. Witnesses--Jan Mead, Dyrck Dey, Henry Brockholls. Proved Dec. 8, 1732.

"Gillis Jansen De Mandeville, from Garderen (Gillis Jansen Van Garder on passenger list<sup>4</sup>), in the Veluwe, Gelderland, ancestor of the American family of Mandeville came out in *de Trouw* [the ship Faith, a private trader going to the Manhattens," which sailed February 13, 1659...Gillis (often written Yellis) or Giles De Mandeville was accompanied by his wife Elsie Hendricks and four children, having two born afterward, one being David. Yellis bought a farm at Flatbush, which he finally gave to his eldest son Hendrick, and got the grant of another, of 30 acres, at Greenwich, on Manhattan Island, laid out to him December 5, 1670, and patented December 30, 1680. Here he died between 1696 and 1701. All of his children married. He had but the two sons, both of whom left descendants. David remained on the farm at Greenwich. Hendrick removed from Long Island to Pequannock, N.J. These have given several pastors to the Reformed Church, including Rev. Giles Henry Mandeville, D.D." — Riker, James, History of Harlem, p. 100f

The Mandeville estate extended from below 14th street to 21st street, though not parallel to wither, and from the Hudson River to Warren Road. This part of Manhattan Island was known as Greenwich, Sappokaniken, Shappanaconk, or New Nordwyck.<sup>4</sup>

His will was written on 15 Sep 1696, probated 22 May 1701. John Nanfan, Lieut. Governor, Commander in Chief, etc. Know ye that at New York on the 22d day of May, 1701, the last will of Jellis Mandeville of New York was presented and proved. -- Jellis Mandeville, New York. "I, Jellis Mandeville of Greenwich, in the city of New York, being of sound and perfect health." Leaves to wife Elsie all estate during widowhood. "I give to my son Hendrick Mandeville, in preference to all other gifts and in regard of his being my eldest son, all that my farm in Queens County, in the jurisdiction of Hempstead," with houses, barns, etc. To son David, in consideration of his great services, my negro Peter and £50." All the rest of estate is left to his children. Hendrick, David, Tryntie, wife of Cornelis Jansen Secum (?), Helike [Aeltje], wife of Lawrence Johnson

[Jansen], Geritie, wife of Peter De Milt [Meet], and Gertrude [Grietje], wife of John Meetham [Meet]. I specially command that my farm or Bowery at Greenwich be sold with the horses, etc., to the highest bidder of my children and the money to be divided. Makes wife Elsie, sole executor. Dated September 15, 1696. Witnesses, Symon Brestede, Samuel Bayard.<sup>6</sup> In vol. 16 of the NY Historical Soc. Abstracts of Wills there is a correction for vol 1, p. 102 that adds: "Will of Jellis Mandeville was proved May 22, 1701." They also correct John Meetham to John Meet.

He served as "petty constable" of the Bowery Division in 1728, 1729, 1749, and 1750 (NY Court Rec. 1684-1760, p.96). In 1730 "Jelles Mandeviel" was assessed for £5, and "David Mandeviel" for £30, in the Bowery Division of the Outward (Record 95:201). In 1738 Jelyes and John Mandevl were both listed as members of the NY Volunteer Co. under Captain Gerard Stuyvesant's Co. (Hastings Vol. 1 p.584). On 6 Aug 1740, he was registered as a freeman in NYC as a yeoman, or farmer who owned his land (NYHS 18:141). "Jellis Mandeviel" joined the NY RDCh. on 30 May 1759 (Record 61:173). He died in 1778, and was bur. in a family vault near Washington St., at the southwest corner of the Mandeville farm.<sup>2</sup>

Jellis Mandeville's will was dated 6 Feb 1778; probated 27 July 1778 (YW 9 :38). In it he mentioned "(1) Daughter Mary, wife of Matthew Buyce. (2) 4 grandchildren, children of dau. Hannah, dec'd, Jellis Gilbert, Aaron Gilbert, Mary Gilbert, and Rachel Gilbert. (3) "I leave to the children of my daughter Mary, and the children of my son Matthew, and the children of my son Jeremiah, dec'd. and the children of my dau. Hannah, dec'd all the rest of my estate, real and personal." (His grandchildren were: John Buyce, Rachel Hopwood, Mary Waldron, Hannah Higgins, Jellis M. Buyce, Jellis Mandeville, Rachel Beat-tie, Euphemia Clark, Yellis, John and Matthew Mandeville, Lea Delamater, Aaron Gilbert, Mary Van Beuren, Rachel and Yellis Gilbert.<sup>3</sup>)

The will mentioned: dau. - Mary (wife of Matthew Buyce) 10 acres of land bounded by the estate of Sir Peter Warren and Hudson River plus 6 acres of woodland; 4 gr.children - Jellis Gilbert, Aaron Gilbert, Mary Gilbert, and Rachel Gilbert (children of dau. Hannah dec'd.) similar parcels of land; both plots were to have "a cartroad to be left through said Weyland from highroad to Hudson." To the children of my dau. Mary, and the children of my son Matthew, and the children of my son Jeremiah dec'd. and the children of my dau. Hannah dec'd., the rest of my estate real and personal. Also mentioned vault, together with the grounds thereabout, at Sir Warren's corner for burial of all my children and gr.children. Exr: friend Nicholas Stuyvesant and son-in-law Matthew Buyce (NYW 9:38-40). Land records indicate he had 16 gr.children who shared in the estate (Record 38:291 footnote). The land was described in 1901 by William S. Pelletreau as "bounded on east by the Fitzroy

Rd. which was a little east of 8th Avenue, to the junction of Greenwich avenue and 8th avenue to the junction of Greenwich street and 9th avenue and the same course to the river [Hudson]. It was bounded west by the river and north about 21st street," (NYW 9:39-40). In 1780, the heirs of Yellis Mandieville owned a farm of 35 acres, another of 60 acres and a third of 4 acres "at the Great Kills and Greenwich along the North [now Hudson] River." References: Hendricks #34 (Rev'd. in GMNJ 46:114), Record 38:291-293, 40:124; 122:201; NY Guardians p. 190; Mandeville p. 43, #17; See Stokes Iconography (Vol. 6) pp. 118-119 for more on the Mandeville lands.<sup>2</sup>
