The family groups represented in this collection may not be complete, because information was entered bit by bit as I found it or happened upon it; I have not done any systematic research on these families. Because they do not compose whole family genealogies, these listings are arranged differently from most genealogical records or histories. Each listing is a family group, and is arranged and filed alphabetically under the name of the head of the family.

Names are generally in alphabetical order (disregarding spelling variations and middle names), then in approx. chronological order. The first sorting is by surname (mixing together any and all spelling variations), then by given name, then by approximate birthdate (when known) in approximate chronological order. For easier reference, surnames in headings are grouped together under the most common spelling usage that evolved in this geographical location, regardless of individualistic spellings in the records themselves. Cross references are used in most cases where surname spellings substantially vary.

Within the quoted records, the individual spellings have been (mostly) retained because they sometimes provide clues (although in general—but with exceptions—they seem to largely reflect the record keeper's particular orthography and not always, at this early period, any special family preference). Those interested can see the variety and evolution of a particular name's spelling and the interesting and sometimes amusing attempts at phonetic reproduction. Keep in mind that before names and spellings were standardized, records reflected the individualistic whim of the particular recorder (often two different spellings of the same name within the same document). In addition, all records were handwritten, and sometimes deciphering a handwritten name in early records can be quite challenging! So expect to search under all possibilities of spelling (for both surnames and given names).

Given names are grouped together without regard for middle initials or middle names. Because middle names and/or initials are sometimes used, sometimes not used in various records, it seemed simplest to arrange entries as if the middle names or initials did not exist. Usually all variations of a given name are grouped together as though spelled one way: Jan, Johannes, John, etc. are all grouped as one (but also look under the other forms).

Sources and references are included with each "family" grouping, but may or may not include sources that are cited (or are obvious, such as baptismal records, etc.) within the narrative or listing itself.

As with any compiled genealogical record, researchers should regard this information as leads and clues, and should verify all data with independent research.

I welcome, and would be grateful for, any additions or corrections, especially with source citations.

Jean de la Mantagne was a French Huguenot refugee, from a Walloon family. He lived in Leyden, Holland. He was educated as a doctor of medicine. He made several trips abroad and on one of his return trips, he married in Holland. He was a member of the Council of the Director-General, 1638-56; was Commander of Fort Good Hope in 1641; was a member of Convention 1653; was a Commissioner to Investigate the Conspiracy of Dutch and Indians against England in 1655; and was sent to New Netherlands as Vice Director of Fort Orange, 1656-1664.

Abraham Montanye was the proprietor of the King's Arms (Montagne's Tavern, 253 Broadway) as listed in the New York Directory of 5 April 1774. He had taken the tavern over from Edward Bardin in April 1769. This tavern had been operated since April 1769 by Abraham de la Montagne, Marretje/Maria Remsen's first husband. According to p. 160 Colonial Taverns and Tavern Keepers, this tavern “immediately became the meeting place of the less militant faction of the Sons of Liberty.”¹

Marretje/Maria Remsen m. (2) 28 Dec 1777, **John Amory**. John Amory offered the tavern for rent 17 Sep 1781 and again on 8 June 1782. His widow opened it as the “Vauxhall” on 22 June 1793.¹

Jean de la Mantagne was a French Huguenot refugee, from a Walloon family. He lived in Leyden, Holland. He was educated as a doctor of medicine. He made several trips abroad and on one of his return trips, he married in Holland. He was a member of the Council of the Director-General, 1638-56; was Commander of Fort Good Hope in 1641; was a member of Convention 1653; was a Commissioner to Investigate the Conspiracy of Dutch and Indians against England in 1655; and was sent to New Netherlands as Vice Director of Fort Orange, 1656-1664.

Jean Mousnier de la Montagne was supposedly a native of Saintonge on the west coast of France. He first appears on record on 19 Nov 1619 when he registered as a student of medicine at the University of Leyden, signing his name in Latin as Johannis Monerius Montanus from Xanto. He was 24 years old in 1619; thus he was born in 1595.¹

A "Promise of certain Walloons and French to Emigrate to Virginia", written in French and dated 5 February 1621, was submitted to Sir Dudley Carleton, British Ambassador in Holland. This petition applied for permission to settle in Virginia, fifty or sixty families, Walloon and French, all of the reformed religion. Among the signatures are those of Mousnier de la Montagne, medical student; Mousnier de la Montagne, apothecary and surgeon; Henry Lambert, woolen draper; Jan DeCroy (Cray), sawyer with wife and five children; Pierre Quesnee (Chesne), brewer; Jesse DeForest, dyer with wife and five children; Jan Gille (Verbrugge?), labourer with wife and three children; Jan DeTrouw (deTrieux), wool carder, with wife and five children; Jean Campion, wool carder; Philippe Campion, draper; et.al.²

At the (1) marriage, the bridegroom's witness was his "friend" Gerard de Forest [uncle of the bride?], and Rachel's witness was her aunt, Hester de la Grange, Gerard's wife.³

On 25 Sep 1636 he sailed for America with his wife and three children on the ship *Rensselaerswyck* owned by the *Patroon* Kiliaen Van Rensselaer and by the DeForest family, whose leader was Rachel's uncle, Gerard DeForest. A fourth child, Maria, was born to Rachel at sea before the ship reached New Amsterdam on 5 March 1737.¹

In New Netherland Jean Mousnier de la Montagne set up business as a physician and chandler in New Amsterdam. His brother-in-law, Henry DeForest died soon after arrival, and Johannes took charge of the DeForest tobacco plantation in mid-Manhattan; eventually he assumed the proprietorship of the property and lived there. This farm, called *Vredendal*, included much of the upper half of what is now Central Park in New York City.¹

Jean de la Montanye taught school under appointment from Holland to New Netherlands. On a trip back to Holland, he married in 1655. He returned to New Netherlands, but his wife remained in Holland until after the birth and baptism of her son. She then came to New Amsterdam on the ship, *King Solomon*.

Upon the institution of Burghers rights, Jean de la Montanye was the first to enroll on the lists of Great Burghers, in April 1657. He was fire warden in 1658.

His second wife, Maria Farnelie was a "j.d. Van Leÿden." Maria Vermilye, widow of Jean de la Montagne, m. (2) 26 Sep 1675 New Haarlem, **Isaac Kip**, widower of Catalyntje Snyers, and son of Hendrick Kip.
